# About NEP 2020 Policy

## Introduction

Higher education plays an extremely important role in promoting human as well as societal well-being and in developing India as envisioned in its Constitution - a democratic, just, socially conscious, cultured, and humane nation upholding liberty, equality, fraternity, and justice for all. Higher education significantly contributes towards sustainable livelihoods and economic development of the nation. As India moves towards becoming a knowledge economy and society, more and younger Indians are likely to aspire for higher education.

NEP 2020 focuses on five pillars: Affordability, Accessibility, Quality, Equity, and Accountability - to ensure continual learning. It has been crafted consistent with the needs of the citizens as a demand for knowledge in society and the economy called for a need to acquire new skills regularly. Thus, providing quality education and creating lifelong learning opportunities for all, leading to full and productive employment and decent work as enlisted in United Nations Sustainable Development Goals 2030, forms the thrust of NEP 2020. The global education development agenda reflected in Goal 4 (SDG4) of the 2030 Agenda for Sustainable Development, adopted by India in 2015 - seeks to "ensure inclusive and equitable quality education and promote lifelong learning opportunities for all" by 2030.

Understanding the importance of NEP 2020, Vidyapeeth is going to implement the NEP 2020 Policy from this academic year 2023-24.

- Undergraduate education can be of 3 or 4 years with multiple exit options and appropriate certification at different stages.
- Opportunity for learners to choose the courses of their interest in all disciplines.
- As per the NEP 2020, the students will now have options of multiple exits during their UG programme. For example, a student can exit just after 1st year of graduation with a certificate in hand. If he/she opts to exit after the second year, Diploma will be awarded for 2 years of successful completion of the study. As usual, the 3rd year of UG completion will result in a Bachelor's Degree and 4th year of UG completion will be awarded a Bachelor's degree with Honors.

- Multidisciplinary and holistic education across the sciences, social sciences, arts, humanities, and sports for a multidisciplinary world to ensure the unity and integrity of all knowledge.

- An Academic Bank of Credit (ABC) shall be established, which would digitally store the academic credits earned from various recognized Higher Education Institutions so that the degrees from a Higher Education Institution can be awarded taking into account credits earned.
- In honestly and faithfully implementing the NEP 2020 Policy, the authorities of TMV have tentatively prepared an action plan that will be implemented in a phased manner to achieve the goals/ objectives of the NEP 2020 Policy.
- The Vidyapeeth will continue to issue the necessary directions/ instructions to all the concerned for this purpose.

## Examination Department NEP Rules

### • Awarding of UG Certificate:

Students who opt to exit after completion of the first year and have secured 40 credits will be awarded a UG certificate if, in addition, they complete one skill course of 4 credits and 6 internship/job related/ based credits at an additional cost \*decided by the Vidyapeeth during the summer vacation of the first year. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of seven years.

### • Awarding UG Diploma:

Students who opt to exit after completion of the second year and have secured 80 credits will be awarded the UG diploma if, in addition, they complete one vocational course of 4 credits and 6 internship/job related/ based credits at an additional cost decided by the Vidyapeeth during the summer vacation of the second year. These students are allowed to re-enter within a period of three years and complete the degree programme within the maximum period of seven years.

### • Validity of PRN:

In any case after opting for multiple entry /exit the validity of PRN will not be more than 7 years. After 7 years a student shall take a readmission and start fresh.\* The maximum duration to allow re-entry: Re-entry for a program is allowed a maximum of up to 3 years once in the duration of 7 years of validity of a PRN. (PRN validity table attached)

### • Lateral entry :

A student joining from another university/institute to complete a particular program at TMV under multiple entry/exit of NEP would be required to undertake an introductory course which will be a pass-or-fail course with no credits. Please refer to the respective academic department for such requisites.

- **Credit validity from other HEI:**

The procured credits in any semester by the student from another HEI would be valid and granted provided the student submits a certificate duly signed by the competent authorities of that HEI. The certificate should mention the grade on 10 point scale. The such original certificate should be submitted to the Academic Department not after (Latest by) the 15 days of the last day of the semester-nd examination of that Academic Department. TMV would not be liable or responsible for any academic loss of a student if the other HEI could not issue the course completion certificate on time.

- **Charging fees after re-entry:**

A student re-entering a particular program after a gap would be charged fees as per that particular Academic Year and not as per the batch year fee of the student to which he was admitted.

- **ABC Enrolment:**

A student should enrol for ABC at the time of enrolment and submit his ABC ID to the Academic department. Admission will not be confirmed without submission of ABC ID.

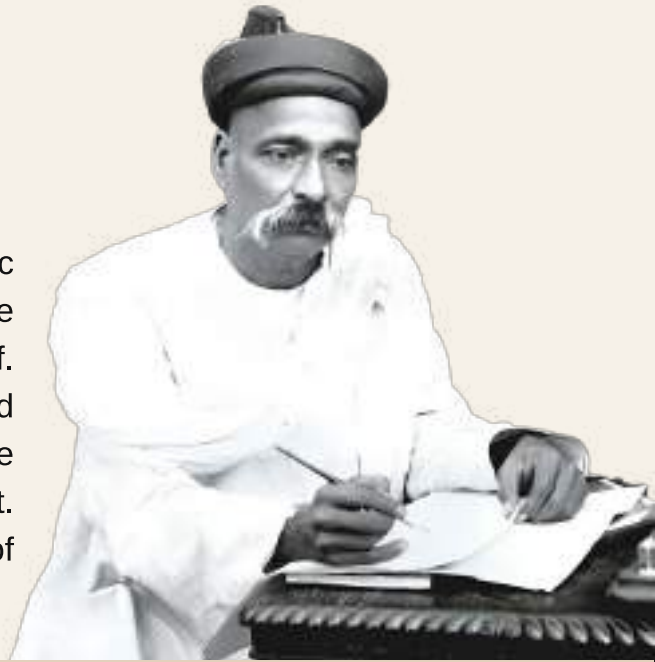

# TILAK MAHARASHTRA VIDYAPEETH PUNE

## A rich legacy of 100 years in the field of education

INDIA'S STRUGGLE for freedom was a dynamic process in which a nation was punctuating, became conscious of new aspirations and realized its best self. ## EDUCATION

Lokmanya Tilak established New English School in 1880 & Fergusson College in 1885 along with his friends. Education according to them was a very good platform for implementing their ideas of national education and to mould generation which will help build modern and strong India. The origin of the Vidyapeeth dates back to pre-independence period - 1921 when immediately after the demise of Lokmanya Bal Gangadhar Tilak, his follower Mahatma Gandhi mooted the idea of establishing an university in his memory.



## UGC RECOGNITION

**NAAC Reaccredited (Third Cycle) with 'B++' grade Legacy of 100 years in the field of education**

Though late, i.e. after 66 years of establishment of Vidyapeeth, it was only in the year 1987 that the UGC (University Grants Commission) took cognizance of significant work of TMV in the fields of Sanskrit, Ayurveda, Social Sciences and Distance Education and thereby on its recommendations, the Government of India conferred the "Deemed to be a University" status upon Tilak Maharashtra Vidyapeeth. With this conferment of "Deemed to be a University" status, the Vidyapeeth gained recognition at the national level. 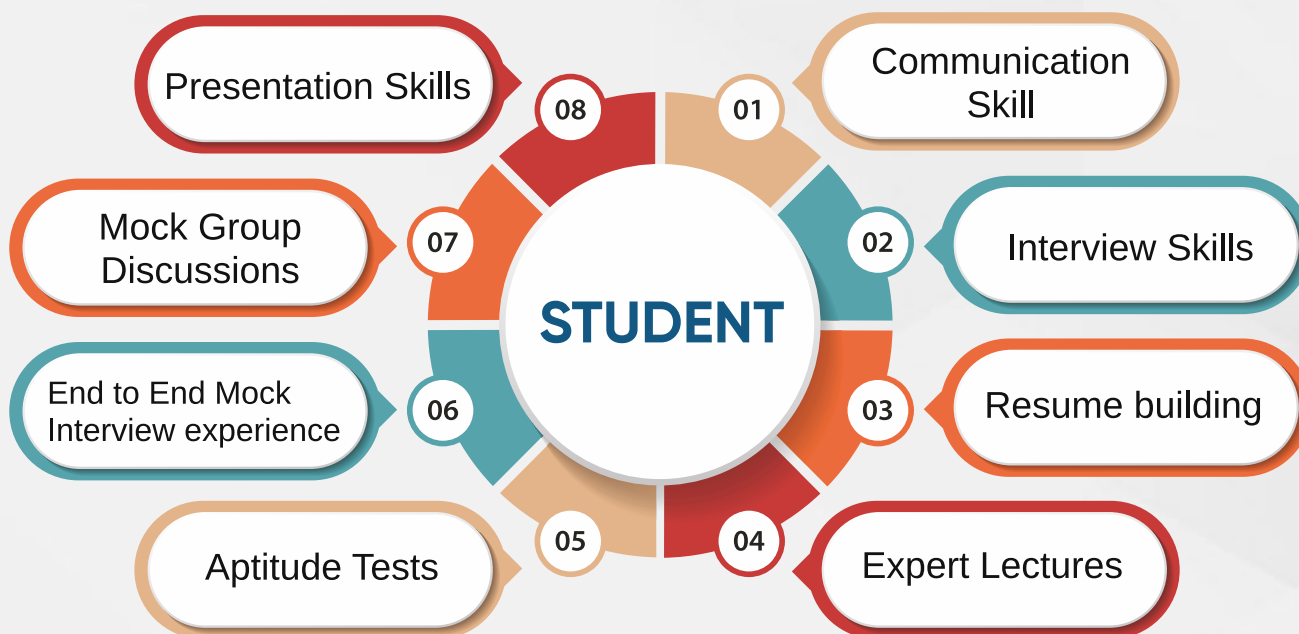
